



#### RAILROAD-HIGHWAY CROSSINGS PROGRAM

#### HIGHWAY SAFETY IMPROVEMENT PROGRAM

### Highway Safety Improvement Program (HSIP) North Dakota Division Office

### **Core Federal-Aid program**

- Purpose: achieve a significant reduction in fatalities and serious injuries on all public roads
- Approx. \$2.5 billion annual nationwide apportionment
   Railway-Highway Crossing Program (RHCP) set-aside
- HSIP is for ALL public roads
- All highway safety improvement projects must:
  - ✓ Be consistent with the State SHSP
  - Correct or improve a hazardous road location or feature or address a highway safety problem

- Federal Aid provides 90% funding of the improvement costs.
- NDDOT has committed half of their HSIP budget for local road improvements
- The LRSP's already have the forms filled out; however, the owners must submit them to NDDOT annually.
